OVERVIEW

THE ITALIAN INCENTIVE SCHEME is regulated by Law 220/2016, which envisages a Fund for promoting investment in the film and audiovisual industry (films, TV and web programmes and series, documentaries, animations, shorts and interactive narrative games).

OVER THE YEARS, the endowment has increased to a minimum annual budget of 700 million euros and is focused on accelerating export growth, boosting revenues and deepening international relationships. 60% of this national fund is allocated to the support to audiovisual works.

AN ITALIAN PARTNER is necessary to have access to national and regional incentives and to tax credits. Finding the right Italian partner with the same creative vision is key to the success of any project. The Directorate General for Cinema and Audiovisual of the Ministry of Culture (DGCA-MiC) cannot recommend specific Italian companies, but several sources will help you identify potential partners, such as <https://filmmitalia.org/en/industryidx/0/>.

CO-PRODUCTIONS

AN OFFICIAL ITALIAN CO-PRODUCTION is a film production made by Italy with one or more countries under one of Italy's official co-production agreements or the European Convention on Cinematographic Co-Production.

ALL AGREEMENTS HAVE DIFFERENT REQUIREMENTS. The common principles are:

- A co-producer from each co-producing country needs to make both financial and effective creative, technical and artistic contributions to films, which need to be broadly proportional
- Contributions need to be made mainly by using staff, goods and services from the co-producing countries
- Films need to be made in the co-producing countries (you may be able to shoot in a third country location and third country staff may be allowed, but not in excess of 20-30% of the budget, depending on the applicable agreement)
- The co-production status must be applied before principal photography begins.

CO-PRODUCING ALLOWS pooling of creative, financial, technical expertise and resources as well as sharing of risks.

AN ITALIAN FILM qualifying as an official co-production is eligible to apply for:

- Tax credit for domestic productions and co-productions
- Selective contributions
- Automatic contributions

CO-PRODUCING WITH ITALY also allows access to the following incentives:

- Eurimages – co-productions with member countries (films).
- Media – co-development films and audiovisuals with member countries.

TAX CREDIT FOR DOMESTIC PRODUCTIONS AND CO-PRODUCTIONS

- **TAX CREDITS ARE WAYS OF OFFSETTING** the tax and social security debts of companies and are automatically calculated based on the costs incurred in the development, production and distribution - both in Italy and abroad - of feature films, short films, TV series, documentaries, animations, web products and videogames. The rate for film and audiovisual productions may reach 40% of the eligible costs.
- **THE TAX CREDIT IS IMMEDIATELY AVAILABLE** as a monthly tax deduction and is paid in Italy by a local executive producer. Moreover **IT CAN BE TRANSFERRED TO BANKS**, thus converting it into a direct contribution.
- **ELIGIBLE COSTS:** the tax credit is cumulative with other public aid, in accordance with European legislation.

FOR CO-PRODUCED WORKS

- Eligible costs are based on the Italian company's share of participation. If the Italian company, as executive producer, incurs expenses on Italian soil exceeding its own share, those expenses are factored in the eligible cost.
- Cap per project: the maximum funding limit per project can reach up to 18 million, as opposed to the 9 million allocated for fully Italian works.

SELECTIVE CONTRIBUTIONS

- **THE 91,5 MILLION EURO CALL** for proposals is granted for writing, developing, producing and distributing audiovisual works in Italy and abroad, as well as for promoting them. The projects are selected by experts based on qualitative assessments. Works produced in collaboration with foreign countries receive an automatic score, which is added to the discretionary score awarded by the evaluation commission. **THE GRANTS AWARDED** are mainly film-oriented, with particular regard to specific categories (young authors, debut and second works, particularly artistic films, short films, animations and documentaries). Since 2024, a new strand dedicated to films and series aimed at promoting national culture and identity has been implemented. Selective contributions are granted to individuals, companies or entities to implement a work or project. They are non-refundable grants and are allocated through appropriate calls.

AUTOMATIC CONTRIBUTIONS

■ **THE 37,6 MILLION EURO CALL** for proposals is granted for the development, production and distribution of new works under the following conditions:

- a) for films, to cover necessary investment during the development, production, national and international distribution and home entertainment distribution;
- b) for television and web works, to cover necessary investment for development, production, international distribution and home entertainment distribution.

THE VALUES OF RESULTS are automatically assigned through a scoring system.

The work made in cooperation with a foreign producer is considered as a cultural parameter, thus entitling to a score

BILATERAL FUNDS

THE DGCA - MIC has set up ad-hoc co-development bilateral funds, in collaboration with the equivalent bodies of individual countries to support the implementation of international co-production projects and promote production relations with target markets.

THE CO-DEVELOPMENT FUNDS currently in force include:

1. Italy-Portugal
2. Italy-Tunisia
3. Italy-Baltic Countries
4. Italy-France (the co-development fund applies not only to films but also to TV and web series. In addition, there is also a specific co-production fund with France).

MINORITY CO-PRODUCTIONS FUND

THE 6 MILLION EURO CALL for proposals governs the granting of contributions for the production of feature films made in co-production or co-participation with other countries, where Italian participation has a minority share.

This grant is non-refundable and can be applied for upon completion of the work, with a maximum contribution of 300,000 euros.

AN ITALIAN COMPANY applying for the above fund must:

- Be qualified as an independent producer
- Own at least 20% of copyrights to the relevant work (10% if companies from more than two countries are involved).

FOR WORKS TO BE CONSIDERED ELIGIBLE, certificates must be provided proving that at least 50% of the funds required to cover production costs have been secured.

CONTRIBUTIONS ARE PAID AS FOLLOWS:

- The beneficiary may request a 60% advance payment of the grant within 18 months from the date of publication of selection results
- The DGCA-MiC will release the funds within 90 days
- The remainder of the grant must be claimed within 24 months from the date of publication of selection results (within 36 months for animation projects)
- The DGCA-MiC will release the remaining sums within 90 days.

UNOFFICIAL CO-PRODUCTIONS

ITALY CAN ALSO CO-PRODUCE with countries with whom it does not have any agreements. These works may still be considered Italian as co-participated works (films) or as international productions (TV and web works). In this case, the granting procedure requires extra steps compared to the procedure followed for co-productions:

- International co-participations – films made with countries with whom NO specific co-production agreements are in force: the minimum share of participation in production is 20%
- International productions – non-film audiovisual works made with countries with whom NO specific co-production agreements are in force: the minimum share of participation in production is 20%.

FOREIGN PRODUCTIONS: WHY FILMING IN ITALY

TAX CREDITS FOR ATTRACTING INVESTMENT in films and audiovisual works made in Italy allow companies to offset tax liabilities such as IRES (corporate income tax), IRPEF (personal income tax), IRAP (regional tax on productive activities), VAT, social security and insurance contributions with credits accrued on film production investments. They target Italian Production Service Companies that make films, or portions of films, in Italy on behalf of foreign production companies.

FOR TAX RELIEF PURPOSES, qualifying expenditure is defined as that which is used and consumed on Italian soil. All eligible costs need to be incurred by Italian executive producers since the relevant tax relief is claimed through the company's corporate tax return.

THE MAIN FEATURES

- **Tax Credit Rate:** 40% tax credit on the eligible cost of productions. A 30% rate applies to above-the-line costs related to non-European subjects only;
- **Cap:** a maximum of 20 million per year per company, allocated through an Italian executive producer. There is no maximum limit per work. In any case, the national production tax credit, when used by the same company, is not included for the purposes of calculating the limit of 20 million per year;
- **Eligible projects:**
 - feature films;
 - short films;
 - TV series;
 - documentaries;
 - animations;
 - web products
- **Eligible Activities:** all forms of production activities are eligible for the tax credit. Shooting in Italy is not mandatory; post-production activities also qualify.
- **Minimum Spent:** Production companies must spend at least
 - 250.000 € in Italy.
- **Availability:** the tax credit is immediately available as a monthly tax deduction and is paid in Italy by a local executive producer. The tax credit can be used even during filming.
- **Transferability:** the tax credit can be transferred to banks, thus converting it into a direct contribution.

REGIONAL FUNDS

IN ADDITION TO THAT, there are Regional Funds for a total amount of about 70 million euros at a national level, dedicated to support national and international productions.

THESE FUNDS ARE MANAGED by the Regions and/or the 20 film commissions that are members of the IFC (Italian Film Commissions) and are located all over Italy. IFC members provide locations and services, logistic assistance, access to financial resources, assistance on permits, qualified crews and service providers.

REGIONAL FILM COMMISSIONS will help you find creative co-producers, pristine locations and source local talent and crews. In many instances they also provide information and networking opportunities for industry professionals and help liaise with local film festivals, workshops and other events.

THE AMOUNT OF FUNDING PROVIDED can vary depending on the project and the commission involved. Most film commissions award funding on a points basis via a panel of industry experts who evaluate productions using criteria such as artistic merit, potential impact on the local industry and the amount of time spent shooting in the region.

FILM DISTRIBUTION FUND

THE FILM DISTRIBUTION FUND is a support scheme introduced into the Italian legislation by Law no. 220 of 2016, Art. n. 10, n. 26 and n. 27, for the granting of contributions to support the distribution of Italian films with primary theatrical exploitation beyond Italian borders. The contribution is part of the Fondi Internazionalizzazione and is regulated by the 2024 Guidelines published with Directorial Decree of September 13th, 2024 n. 3091.

THE 2024 FUND IS EQUAL to 1,600,000 euros, divided into 2 calls of 800,000 euros each for requests relating to theatrical distribution. The beneficiaries are foreign distributors with registered offices throughout the world except Italy, San Marino and Vatican City. For applications relating to theatrical distribution, the maximum contribution that can be requested is 50,000 euros.
